BY-LAW No. 15-2016

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting the renaming of Markham Avenue, between Airdrie Road and Laird Drive, to "Stickney Avenue".

The North York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
