**CITY OF TORONTO**

**BY-LAW No. 16-2016**

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Saranac Boulevard.**

The North York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Saranac Boulevard	North	Bathurst Street and a point 115 metres west	Anytime
Saranac Boulevard	West and north	Covington Road and a point 115 metres west of Bathurst Street	1:00 a.m. to 6:00 a.m.

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Saranac Boulevard	North	Bathurst Street and a point 131 metres west	Anytime
Saranac Boulevard	West and north	Covington Road and a point 131 metres west of Bathurst Street	1:00 a.m. to 6:00 a.m.

C. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time and/or Days)	(From Column 5 Maximum Period Permitted)
Saranac Boulevard	South	A point 30 metres west of Bathurst Street and a point 83 metres west of Bathurst Street	6:00 a.m. to 6:00 p.m.	15 mins.

D. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time and/or Days)	(In Column 5 Maximum Period Permitted)
Saranac Boulevard	South	A point 30 metres west of Bathurst Street and a point 53 metres further west	6:00 a.m. to 6:00 p.m., Mon. to Fri.	15 mins.
