BY-LAW No. 181-2016

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Abell Street and Lisgar Street.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Abell Street	East	Queen Street West and the south end of Abell Street	Anytime, from the 16th day to the last day of each month, Apr. 1 to Nov. 30, inclusive
Abell Street	West	Queen Street West and the south end of Abell Street	Anytime, from the 1st day to the 15th day of each month, Apr. 1 to Nov. 30, inclusive; Anytime, from Dec. 1 of one year to Mar. 31 of the next following year, inclusive

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Abell Street	East	Queen Street West and Sudbury Street	Anytime
Abell Street	West	Sudbury Street and a point 20.5 metres north	Anytime

C. By inserting in Schedule XVIII (One-Way Highways) in § 950-1317, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Times and/or Days)	(In Column 4 Direction)
Abell Street	Queen Street West and Sudbury Street	Anytime	Southbound
Lisgar Street	Queen Street West and Sudbury Street	Anytime	Northbound

D. By deleting from Schedule XXVII (Compulsory Stops) in § 950-1326, the following in alphabetical order by street name:

(From Column 1 Intersection)	(From Column 2 Stop Street or Highway)
Lisgar Street and Sudbury Street	Lisgar Street

E. By inserting in Schedule XXVII (Compulsory Stops) in § 950-1326, the following in alphabetical order by street name:

(In Column 1 Intersection)	(In Column 2 Stop Street or Highway)
Abell Street and Sudbury Street	Abell Street (southbound)

F. By inserting in Schedule XXX (Heavy Vehicles Prohibited) in § 950-1329, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Prohibited Times and/or Days)
Abell Street	Queen Street West and Sudbury Street	Anytime

G. By inserting in Schedule XXXV (Speed Limits on Public Highways) in § 950-1334, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Speed Limit (km/h))
Abell Street	Queen Street West and Sudbury Street	30
