**CITY OF TORONTO**

**BY-LAW No. 362-2016**

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Bayview Avenue, Cooperage Street, Eastern Avenue, Front Street East, Lawren Harris Square, Mill Street, Palace Street, Rolling Mills Road, Tannery Road and Trolley Crescent.**

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
