**CITY OF TORONTO**

**BY-LAW No. 372-2016**

**To amend City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to include the new CityPlace and Fort York Business Improvement Area and to establish a Board of Management for the CityPlace and Fort York Business Improvement Area.**

Whereas Council, by the adoption of By-law No. 245-2016, authorized the designation of an area bounded by Spadina Avenue to the east, Lake Shore Boulevard West to the south, Strachan Avenue to the west and Front Street West and the CNR Corridor to the north, as a business improvement area under Municipal Code Chapter 19, Business Improvement Areas; and

Whereas Toronto and East York Community Council has established a board of management for the CityPlace and Fort York Business Improvement Area, and appointed members to the CityPlace and Fort York Business Improvement Area Board of Management for a term expiring on November 30, 2018, or as soon thereafter as successors are appointed; and

Whereas Schedule A of Municipal Code Chapter 19, Business Improvement Areas, must be amended to include the new CityPlace and Fort York Business Improvement Area Board of Management;

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 19, Business Improvement Areas, is amended as follows:
  - (1) The table in Schedule A, Boards of Management is amended by adding the new CityPlace and Fort York Board of Management as set out in Schedule A attached; and
  - (2) Schedule A, Maps is amended by adding the attached map of the CityPlace and Fort York Business Improvement Area.
2. A Board of Management for the CityPlace and Fort York Business Improvement Area is established.
