**CITY OF TORONTO**

**BY-LAW No. 750-2016**

**To amend City of Toronto Municipal Code Chapter 546, Licensing of Vehicles-For-Hire, to make technical amendments required for codification.**

Whereas under Section 169-26B of City of Toronto Municipal Code Chapter 169, Officials, City, the City Solicitor, in consultation with the City Clerk, may submit bills directly to Council to make technical amendments to the Municipal Code; and

Whereas at its meeting of May 3, 4 and 5, 2016, City Council adopted Licensing and Standards Committee Item LS10.3, as amended, including resolutions instructing the City Solicitor to create a new chapter of the City of Toronto Municipal Code and to import all relevant general provisions and definitions from City of Toronto Municipal Code Chapter 545; and

Whereas at its meeting of June 7, 8 and 9, 2016, City Council passed By-law No. 575-2016, which enacted the recommendations of Licensing and Standards Committee Item LS10.3, adopted as amended, by City Council on May 3, 4 and 5, 2016 and created Chapter 546, Licensing of Vehicles-For-Hire; and

Whereas City of Toronto Municipal Code Chapter 546, Licensing of Vehicles-For-Hire, requires technical amendments to correct a phrase used in the definition of "Private Transportation Company Vehicle", to import from Chapter 545 the definition of "Service Animal" which was omitted, to correct section numbers erroneously referencing Chapter 545, and to substitute certain phrases with plainer language to improve the readability of Chapter 546;

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 546, Licensing of Vehicles-For-Hire, is amended by replacing the number "545" in § 546-40D and in the headings for §§ 545-59 and 545-60 with the number "546".
2. Municipal Code Chapter 546, Licensing of Vehicles-For-Hire, is amended by replacing the words and phrases found in the listed sections as indicated:

SERVICE ANIMAL - means an animal described in subsection 80.45(4) of O. Reg. 191/11, Integrated Accessibility Standards.
