BY-LAW No. 1247-2016

To amend City of Toronto Municipal Code Chapter 441, Fees and Charges, to enact a new user fee to cover the costs of long-term maintenance of paver installations on City highways by City staff.

Whereas subsection 32(1) of the *City of Toronto Act, 2006*, as amended (the "Act") provides the City the authority to pass by-laws respecting matters related to public highways under its jurisdiction; and

Whereas the General Manager, Transportation Services, processes and reviews applications from parties seeking to install pavers on City highways; and

Whereas Council has directed that a user fee shall be collected from applicants seeking to install pavers on City highways to cover the costs of long-term maintenance of paver installations on City highways by City staff; and

Whereas it is necessary to amend Chapter 441, Fees and Charges, with respect to the fees charged in relation to the long-term maintenance of paver installations on City highways; and

Whereas notice of the intention to enact this by-law has been provided in accordance with the Act and the City of Toronto Municipal Code;

The Council of the City of Toronto enacts:

1. Schedule 2, Transportation Services, of Appendix C of City of Toronto Municipal Code Chapter 441, Fees and Charges, is amended by adding the following:
