## CITY OF TORONTO

### BY-LAW 49-2017

#### To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Beaconsfield Avenue.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 903, Parking for Persons with Disabilities, is amended as follows:
  - A. By deleting from Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time or Days)
Beaconsfield Avenue	East	A point 24.7 metres south of Mackenzie Crescent and a point 5.5 metres further south	Anytime
Beaconsfield Avenue	East	A point 25.5 metres south of Cross Street and a point 5.5 metres further south	Anytime from the 1 <sup>st</sup> day to the 15 <sup>th</sup> day of each month Apr. 1 to Nov. 30, inclusive
Beaconsfield Avenue	East	A point 52.5 metres south of Mackenzie Crescent and a point 5.5 metres further south	Anytime from the 1 <sup>st</sup> day to the 15 <sup>th</sup> day of each month from Apr. 1 to Nov. 30, inclusive
Beaconsfield Avenue	West	A point 21.2 metres south of Cross Street and a point 5.5 metres further south	Anytime from the 16 <sup>th</sup> day to the last day of each month Apr. 1 to Nov. 30, inclusive, and anytime from Dec. 1 of one year to Mar. 31 of the next following year, inclusive
Beaconsfield Avenue	West	A point 21.3 metres south of Mackenzie Crescent and a point 5.5 metres further south	Anytime

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time or Days)
Beaconsfield Avenue	West	A point 42.3 metres north of Cross Street and a point 5.5 metres further north	Anytime from Dec. 1 of one year to Mar. 31 of the next following year, inclusive, and from the 16 <sup>th</sup> day to the last day of each month from Apr. 1 to Nov. 30, inclusive

B. By inserting in Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time or Days)
Beaconsfield Avenue	East	A point 24.7 metres south of Mackenzie Crescent and a point 5.5 metres further south	Anytime from the 1 <sup>st</sup> day to the 15th day of each month from Apr. 1 to Nov. 30, inclusive, and from Dec. 1 of one year to Mar. 31 of the next following year, inclusive
Beaconsfield Avenue	East	A point 25.5 metres south of Cross Street and a point 5.5 metres further south	Anytime from the 1 <sup>st</sup> day to the 15th day of each month from Apr. 1 to Nov. 30, inclusive, and from Dec. 1 of one year to Mar. 31 of the next following year, inclusive
Beaconsfield Avenue	East	A point 52.5 metres south of Mackenzie Crescent and a point 5.5 metres further south	Anytime from the 1 <sup>st</sup> day to the 15th day of each month from Apr. 1 to Nov. 30, inclusive, and from Dec. 1 of one year to Mar. 31 of the next following year, inclusive
Beaconsfield Avenue	West	A point 21.2 metres south of Cross Street and a point 5.5 metres further south	Anytime from the 16 <sup>th</sup> day to the last day of each month from Apr. 1 to Nov. 30, inclusive

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time or Days)
Beaconsfield Avenue	West	A point 21.3 metres south of Mackenzie Crescent and a point 5.5 metres further south	Anytime from the 16 <sup>th</sup> day to the last day of each month from Apr. 1 to Nov. 30, inclusive
Beaconsfield Avenue	West	A point 42.3 metres north of Cross Street and a point 5.5 metres further north	Anytime from the 16 <sup>th</sup> day to the last day of each month from Apr. 1 to Nov. 30, inclusive
