BY-LAW 175-2017

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, to correct an error with respect to the reduction of the speed limit from 40 km/h to 30 km/h on a portion of Sammon Avenue (Ward 31).

Whereas Toronto and East York Community Council, at its special meeting held on June 22, 2015 adopted, as amended, Item TE8.1 entitled "30 km/h Speed Limit on Local Roads in the Toronto and East York Community Council Area"; and

Whereas Toronto and East York Community Council, on September 7, 2015, enacted By-law 1106-2015 to reduce the speed limit from 40 to 30 km/h on local roads in Ward 31; and

Whereas By-law 1106-2015 reduced the speed limit from 40 to 30 km/h on Sammon Avenue, between Coxwell Avenue and Cedarvale Avenue; and

Whereas Sammon Avenue, between Coxwell Avenue and Woodbine Avenue, is classified as a collector road and not as a local road, the speed limit should not have been reduced to 30 km/h on that portion of Sammon Avenue; and

Whereas under Section 169-26 of Chapter 169, Officials, City, of The City of Toronto Municipal Code, the City Solicitor, in consultation with the City Clerk, may submit bills directly to make technical amendments to The City of Toronto Municipal Code and other by-laws to correct technical errors;

The Toronto and East York Community Council enacts:

- 1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
- A. By deleting from Schedule XXXV (Speed Limits on Public Highways) in § 950-1334, the following in alphabetical order by street name:
