## CITY OF TORONTO

### BY-LAW 524-2017

#### To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Balmuto Street.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule VI (Commercial Loading Zones) in § 950-1305, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Location)	(From Column 4 Times and/or Days)
Balmuto Street	West	Between a point 25.5 metres south of Bloor Street West and a point 11.5 metres further south	Anytime

B. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Balmuto Street	East	Charles Street West and Bloor Street West	6:30 p.m. of one day to 8:00 a.m. of the next following day, Mon. to Fri., 6:00 p.m. to 12:00 a.m., Sat.; Anytime, Sun.

C. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Balmuto Street	East	Charles Street West and Bloor Street West	3:30 p.m. to 6:30 p.m., Mon. to Fri.

D. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Balmuto Street	East	Charles Street West and Bloor Street West	Anytime
Balmuto Street	West	A point 25.5 metres south of Bloor Street West and a point 87.5 metres further south	Anytime

E. By deleting from Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Balmuto Street	East	Charles Street West and Bloor Street West	8:00 a.m. to 3:30 p.m., Mon. to Fri.; 8:00 a.m. to 6:00 p.m. Sat.

2. This By-law shall be effective commencing June 1, 2017.
