BY-LAW 531-2017

To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Kippendavie Avenue, Noble Street, Salem Avenue, Wells Street and Woodlawn Avenue West.

The Toronto and East York Community Council enacts:

- **1.** Municipal Code Chapter 903, Parking for Persons with Disabilities, is amended as follows:
- A. By deleting from Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:
