**CITY OF TORONTO**

**BY-LAW 584-2017**

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Danforth Avenue.**

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

| (From Column 1 Highway) | (From Column 2 Side) | (From Column 3 Between)  | (From Column 4 Prohibited Times and/or Days) |
|-------------------------|----------------------|--|--|
| Danforth Avenue         | North                | A point 55 metres west of Coxwell Avenue and a point 106.5 metres east of Coxwell Avenue | Anytime                                      |

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

| (In Column 1 Highway) | (In Column 2 Side) | (In Column 3 Between)  | (In Column 4 Prohibited Times and/or Days) |
|-----------------------|--------------------|--|--|
| Danforth Avenue       | North              | A point 56.4 metres west of Coxwell Avenue and a point 106.5 metres east of Coxwell Avenue | Anytime                                    |
| Danforth Avenue       | North              | A point 56.4 metres west of Coxwell Avenue and a point 15.1 metres further west            | 3:45 p.m. to 4:00 p.m.<br>Mon. to Fri.     |

C. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

| (From Column 1 Highway) | (From Column 2 Side) | (From Column 3 Between)   | (From Column 4 Time and/or Days) | (From Column 5 Maximum Period Permitted) |
|-------------------------|----------------------|---|----------------------------------|--|
| Danforth Avenue         | North                | A point 61 metres east of Greenwood Avenue and a point 55 metres west of Coxwell Avenue | 9:00 a.m. to 6:00 p.m.           | 1 hour                                   |
| Danforth Avenue         | North                | Donlands Avenue and a point 58 metres west of Greenwood Avenue                          | 9:00 a.m. to 6:00 p.m.           | 1 hour                                   |

D. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

| (In Column 1 Highway) | (In Column 2 Side) | (In Column 3 Between)   | (In Column 4 Time and/or Days)         | (In Column 5 Maximum Period Permitted) |
|-----------------------|--------------------|---|--|--|
| Danforth Avenue       | North              | A point 56.4 metres west of Coxwell Avenue and a point 15.1 metres further west | 4:00 p.m. to 6:00 p.m.<br>Mon. to Fri. | 15 mins.                               |
