## CITY OF TORONTO

### BY-LAW 698-2017

#### To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Victoria Street.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule X (Bus Loading Zones) in § 950-1309 the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Location)	(From Column 4 Time and/or Days)
Victoria Street (TO)	West	Between a point 54 metres south of Dundas Square and a point 28 metres further south	Anytime

B. By inserting in Schedule X (Bus Loading Zones) in § 950-1309, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Location)	(In Column 4 Times and/or Days)
Victoria Street (TO)	West	Between a point 48 metres south of Dundas Square and a point 34 metres further south	Anytime

C. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Victoria Street (TO)	West	A point 14 metres south of Dundas Square and a point 3 metres further south	Anytime (motorcycles excepted)
Victoria Street (TO)	West	A 37.5 metres north of Shuter Street and a point 24 metres further south	Anytime

D. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Victoria Street (TO)	West	A 37.5 metres north of Shuter Street and a point 24 metres further north	Anytime

E. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Location)	(From Column 4 Time and/or Days)
Victoria Street (TO)	West	Dundas Square and a point 54 metres south	Anytime

F. By inserting in Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Victoria Street (TO)	West	A point 48 metres south of Dundas Square and a point 34 metres further south	Anytime
