

**CITY OF TORONTO**

**BY-LAW 768-2017**

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Dufferin Street and Springhurst Avenue.**

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By inserting in Schedule V (Stands for Taxicabs) in § 950-1304, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Location)	(In Column 4 Number of Taxicabs)	(In Column 5 Times and/or Days)
Dufferin Street	West	Thorburn Avenue and a point 29 metres south of King Street West	25	Anytime from and including Fri. Aug. 18, 2017 to and including Mon. Sept. 4, 2017

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Dufferin Street	East	A point 15 metres north of Springhurst Avenue and Queen Street West	Anytime from and including Fri. Aug. 18, 2017 to and including Mon. Sept. 4, 2017
Dufferin Street	West	King Street West and Queen Street West	Anytime from and including Fri. Aug. 18, 2017 to and including Mon. Sept. 4, 2017

C. By inserting in Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Dufferin Street	West	Springhurst Avenue and Thorburn Avenue	Anytime from and including Fri. Aug. 18, 2017 to and including Mon. Sept. 4, 2017

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Times and/or Days)	(In Column 4 Direction)
Springhurst Avenue	Dufferin Street and Tyndall Avenue (east branch)	Anytime from and including Fri. Aug. 18, 2017 to and including Mon. Sept. 4, 2017	Westbound

E. By inserting in Schedule XXIII (Prohibited Turns) in § 950-1322, the following in alphabetical order by street name:

(In Column 1 Intersection or Portion of Highway)	(In Column 2 Direction)	(In Column 3 Turns Prohibited)	(In Column 4 Times and/or Days)
Springhurst Avenue and Jameson Avenue	Westbound	Left	7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m., Mon. to Fri., from and including Fri. Aug. 18, 2017 to and including Mon. Sept. 4, 2017
