## CITY OF TORONTO

## BY-LAW 795-2017

To authorize the entering into of an agreement for the provision of municipal capital facilities at various TTC occupied locations.

Whereas Section 252 of the *City of Toronto Act, 2006* provides that the City may exempt from taxation for municipal and school purposes land or a portion of it on which municipal capital facilities are, or will be, located and an agreement for municipal capital facilities may allow for the lease, operation or maintenance of the facilities; and

Whereas subsection 2(1) of Ontario Regulation 598/06 prescribes municipal facilities related to the provision of telecommunications, transit and transportation systems; and

Whereas the Toronto Transit Commission (the "TTC") as tenant has entered into a leases (each the "Lease") with the landlords of the facilities (the "Landlords") for the use of the various premises particularly described in Schedule A hereto (the "Premises") for the provision of transit and transportation systems; and

Whereas Council is desirous of entering into agreements with the Landlords for the provision of municipal capital facilities at the Premises;

The Council of the City of Toronto enacts:

- 1. The City of Toronto is authorized to enter into agreements under section 252 of the *City of Toronto Act, 2006* with the Landlords for the provision of municipal facilities (the "Agreement") at the Premises.
- 2. The Premises are exempt from taxation for municipal and school purposes.
- **3.** This by-law shall be deemed repealed:
  - (a) if the Landlords ceases to own the Premises;
  - (b) if the Premises cease to be used for the provision of telecommunications, transit and transportation systems;
  - (c) when the Lease, or any renewal or extension of the Lease, expires;
  - (d) if the Lease, or any renewal or extension of the Lease, is terminated, for any reason whatsoever; or
  - (e) if the Agreement is terminated for any reason whatsoever.

## City of Toronto By-law 795-2017

- **4.** (1) Sections 1, 3 and 4 of this by-law shall come into force on the day that the by-law is enacted.
  - (2) Section 2 of this by-law shall come into force on the later of the following:
    - (a) the date this by-law is enacted; and
    - (b) the day that the Agreement is entered into by the City and the Landlord.
