CITY OF TORONTO

BY-LAW 800-2017

To amend City of Toronto Municipal Code Chapter 743, Streets and Sidewalks, Use of, to remove stopping, standing and parking offences from the Provincial Offences Act and place them under the Administrative Penalty System for Parking Violations and associated amendments.

The Council of the City of Toronto enacts:

- 1. Chapter 743, Streets and Sidewalks, Use of, of the City of Toronto Municipal Code is amended by:
 - A. Inserting in Subsection 743-1A in alphabetical order a new definition for "Administrative Penalty", "Enforcement Officer", "Penalty Notice" and "Vehicle Owner" as follows:

ADMINISTRATIVE PENALTY – as defined in Chapter 610, Penalties, Administration of.

ENFORCEMENT OFFICER – for the purposes of enforcing § 743-8D(4) or § 743-29I(5), an enforcement officer as defined in Chapter 610, Penalties, Administration of.

PENALTY NOTICE - as defined in Chapter 610, Penalties, Administration of.

VEHICLE OWNER - as defined in Chapter 610, Penalties, Administration of.

- B. Amending the definition of "Officer" in Subsection 743-1D to insert the phrase ", enforcement officer" after the phrase: "by-law officer".
- C. Amending Subsection 743-8D(1) by deleting the word: ", vehicle" so that Subsection 743-8D(1) now reads as follows:
 - (1) Stop, park, place, store, stand or leave any object or thing on a street;
- D. Deleting the "or" at the end of Subsection 743-8D(2).
- E. Deleting the period at the end of Subsection 743-8D(3) and replacing it with: "; or".
- F. Adding a new Subsection (4) to Subsection 743-8D as follows:
 - (4) Stop, park or stand any vehicle on a street.

- G. Deleting the word "and" at the end of Subsection 743-29I(3).
- H. Amending Subsection 743-29I(4) by deleting the phrase: "parked or" such that the Subsection now reads:
 - (4) No private vehicles not actively engaged in the work or temporary street occupation shall be stored on-site; and
- I. Adding a new Subsection (5) to Subsection 743-29I as follows:
 - (5) No private vehicles not actively engaged in the work or temporary street occupation shall be parked on-site.
- J. Amending Section 743-51 as follows:
 - (1) By inserting in Subsection A after the word "offence" the phrase: "or is liable to an administrative penalty".
 - (2) By deleting Subsection B and replacing it with a new Subsection B as follows:
 - B. Unless at the time of the contravention the vehicle was in the possession of another person without the vehicle owner's consent, if a vehicle has been left parked, standing or stopped in contravention of § 743-8D(4) or § 743-29I(5), the vehicle owner shall, upon issuance of a penalty notice, be liable to an administrative penalty.
 - (3) By inserting in Subsection C after the word "chapter" the phrase: ", other than an administrative penalty under § 743-8D(4) or § 743-29I(5), " such that Subsection C will now read as follows:
 - C. Every person convicted of an offence under this chapter, other than an administrative penalty under § 743-8D(4) or § 743-29I(5), is liable to a fine as provided for in the *Provincial Offences Act*.
- 2. This by-law shall come into effect on August 28, 2017.
