## **CITY OF TORONTO**

### **BY-LAW 967-2017**

#### **To amend City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to make changes to the size of various Business Improvement Area Boards of Management.**

Whereas Municipal Code Chapter 19, Business Improvement Areas, designates various areas of the City as Business Improvement Areas; and

Whereas Toronto and East York Community Council, under delegated authority, has approved changes to various Business Improvement Area Boards of Management; and

Whereas Schedule A of Municipal Code Chapter 19, Business Improvement Areas, must be amended to reflect the change in the number of members of the various Business Improvement Area Boards of Management;

The Toronto and East York Community Council enacts:

1. The table in Schedule A of Municipal Code Chapter 19, Business Improvement Areas, is amended as follows:

  - (8) by changing the number of members of the College West Business Improvement Area Board of Management to 7;

- (9) by changing the number of members of The Danforth Business Improvement Area Board of Management to 11;
- (10) by changing the number of members of the Danforth Mosaic Business Improvement Area Board of Management to 21;
- (11) by changing the number of members of the Danforth Village Business Improvement Area Board of Management to 12;
- (12) by changing the number of members of the Gerrard India Bazaar Business Improvement Area Board of Management to 13;
- (13) by changing the number of members of the Hillcrest Village Business Improvement Area Board of Management to 12;
- (14) by changing the number of members of the Leslieville Business Improvement Area Board of Management to 12;
- (15) by changing the number of members of the Liberty Village Business Improvement Area Board of Management to 23;
- (16) by changing the number of members of the Little Italy Business Improvement Area Board of Management to 12;
- (17) by changing the number of members of the Midtown Yonge Business Improvement Area Board of Management to 12;
- (18) by changing the number of members of the Mirvish Village Business Improvement Area Board of Management to 10;
- (19) by changing the number of members of the Mount Pleasant Business Improvement Area Board of Management to 10;
- (20) by changing the number of members of the Parkdale Village Business Improvement Area Board of Management to 12;
- (21) by changing the number of members of the Queen Street West Business Improvement Area Board of Management to 10;
- (22) by changing the number of members of the Roncesvalles Village Business Improvement Area Board of Management to 11;
- (23) by changing the number of members of the Rosedale Main Street Business Improvement Area Board of Management to 13;
- (24) by changing the number of members of the St. Lawrence Market Neighbourhood Business Improvement Area Board of Management to 12;

- (25) by changing the number of members of the Toronto Entertainment District Business Improvement Area Board of Management to 22;
- (26) by changing the number of members of the Upper Village Business Improvement Area Board of Management to 7;
- (27) by changing the number of members of The Waterfront Business Improvement Area Board of Management to 16;
- (28) by changing the number of members of the West Queen West Business Improvement Area Board of Management to 18; and
- (29) by changing the number of members of the Wychwood Heights Business Improvement Area Board of Management to 10.
