BY-LAW 1138-2017

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Agate Road, Downsview Avenue and Victory Drive.

The North York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Agate Road	East	Wilson Avenue and Victory Drive	Anytime
Downsview Avenue	South	Ridge Road and a point 88 metres west	Anytime
Victory Drive	Both	Ianhall Road and Agate Road	Anytime
Victory Drive	Both	Pleasant Home Boulevard and Agate Road	6:00 a.m. to 6:00 p.m., Mon. to Fri.
Victory Drive	North	A point opposite the easterly limit of Pleasant Home Boulevard and Keele Street	6:00 a.m. to 6:00 p.m., Mon. to Fri.
Victory Drive	South	Keele Street and Pleasant Home Boulevard	Anytime

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Downsview Avenue	South	Ridge Road and a point 88 metres west	6:00 a.m. to 6:00 p.m. Mon. to Fri.
Victory Drive	North	Ianhall Road and Agate Road	Anytime
Victory Drive	North	Agate Road and Keele Street	6:00 a.m. to 6:00 p.m., Mon. to Fri.
Victory Drive	South	Julian Road and Keele Street	6:00 a.m. to 6:00 p.m. Mon. to Fri.

C. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Agate Road	East	Wilson Avenue and Victory Drive	Anytime
Agate Road	West	Victory Drive and a point 15 metres south	Anytime
