CITY OF TORONTO

BY-LAW 1180-2017

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Augusta Avenue, Brant Street, Clarence Square, Duncan Street, Portland Street, Princess Street, Victoria Street, Wellington Street West and Widmer Street.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
 - A. By inserting in Schedule V (Stands For Taxicabs) in § 950-1304, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Location)	(In Column 4 Number of Taxicabs)	(In Column 5 Times and/or Days)
Brant Street	East	Between a point 15 metres north of King Street West and a point 24 metres further north	4	Anytime
Portland Street	East	Between a point 15 metres north of King Street West and a point 24 metres further west	4	Anytime
Wellington Street West	North	Between a point 80.7 metres west of Simcoe Street and a point 30 metres further west	4	Anytime
Widmer Street	East	Between a point 15 metres south of Adelaide Street West and a point 24 metres further south	4	Anytime

- B. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Duncan Street	West	Queen Street West and Pearl Street	Anytime
Princess Street	West	King Street East and a point 69.8 metres north	8:00 a.m. to 6:00 p.m., Mon. to Fri.
Victoria Street (TO)	Both	King Street East and Colborne Street	Anytime
Victoria Street (TO)	West	Adelaide Street East and a point 65 metres south	8:00 a.m. to 6:00 p.m., Mon. to Fri.
Wellington Street West	North	A point 60 metres east of Bathurst Street and a point 152.4 metres east of Bathurst Street	6:00 p.m. of one day to 4:00 p.m. of the next following day, Mon. to Fri.; Anytime, Sat., Sun. and Public Holidays

- C. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

Duncan Street	West	Pearl Street and Adelaide Street West	Anytime
Duncan Street	West	Richmond Street West and Queen Street West	Anytime
Victoria Street (TO)	East	Colborne Street and King Street East	Anytime

- D. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time and/or Days)	(From Column 5 Maximum Period Permitted)
Augusta Avenue	West	Richmond Street West and Rush Lane	7:00 a.m. to 5:00 p.m.	1 hour
Clarence Square	North	Spadina Avenue (north intersection) and Wellington Street West	8:00 a.m. to 6:00 p.m.	1 hour
Portland Street	East	Adelaide Street West and Richmond Street West	8:00 a.m. to 5:00 p.m.	1 hour

- E. By inserting in Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Brant Street	East	A point 15 metres north of King Street West and a point 24 metres further north	Anytime
Portland Street	East	A point 15 metres north of King Street West and a point 24 metres further north	Anytime
Wellington Street West	North	A point 80.7 metres west of Simcoe Street and a point 30 metres further west	Anytime
Widmer Street	East	A point 15 metres south of Adelaide Street West and a point 24 metres further south	Anytime

2. This By-law shall be effective commencing November 12, 2017.
