BY-LAW 1184-2017

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Edwin Avenue, Franklin Avenue, Parkman Avenue and Perth Avenue.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Edwin Avenue	West	Ruskin Avenue and a point opposite the north limit of Edith Avenue	Anytime
Perth Avenue	West	The south end and a point 80 metres north of Hugo Avenue	Anytime

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Edwin Avenue	West	A point 15 metres north of Dupont Street and a point opposite the north limit of Edith Avenue	Anytime
Edwin Avenue	West	Ruskin Avenue and Dupont Street	Anytime
Perth Avenue	West	The south end of Perth Avenue and Bloor Street West	Anytime
Perth Avenue	West	A point 15 metres north of Bloor Street West and a point 80 metres north of Hugo Avenue	Anytime

C. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Edwin Avenue	Both	Dupont Street and a point 15 metres north	Anytime
Perth Avenue	Both	Bloor Street West and a point 15 metres north	Anytime

D. By inserting in Schedule XXVII (Compulsory Stops) in § 950-1326, the following in alphabetical order by street name:

(In Column 1 Intersection)	(In Column 2 Stop Street or Highway)
Franklin Avenue and Parkman Avenue	Franklin Avenue
Perth Avenue and Parkman Avenue	Perth Avenue
