BY-LAW 1328-2017

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Mutual Street.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Mutual Street	East	Dundas Street East and lane first south	Anytime
Mutual Street	West	A point 12 metres south of Dundas Street East and a point 11 metres further south	Anytime (car-share vehicles excepted)
Mutual Street	West	A point 12 metres south of Dundas Street East and Gould Street	Anytime
Mutual Street	West	A point 23 metres south of Dundas Street East and a point 6 metres further south	Anytime
Mutual Street	West	A point 29 metres south of Dundas Street East and a point 11 metres further south	Anytime (car-share vehicles excepted)
Mutual Street	West	Shuter Street and a point 40 metres south for Dundas Street East	Anytime

- B. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Mutual Street	East	A point 31.5 metres south of Dundas Street East and a point 64.5 metres further south	Anytime
Mutual Street	West	A point 31.5 metres south of Dundas Street East and a point 59.5 metres further south	Anytime

- C. By deleting from Schedule XLIII (Car Share Vehicle Parking) in § 950-1342, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Number of Spaces)	(From Column 5 Car-share Organization/Company)
Mutual Street	West	A point 12 metres south of Dundas Street East and a point 11 metres further south	2	Zipcar
Mutual Street	West	A point 29 metres south of Dundas Street East and a point 11 metres further south	2	AutoShare

- D. By inserting in Schedule XLIII (Car Share Vehicle Parking) in § 950-1342, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Number of Spaces)	(In Column 5 Car-share Organization/Company)
Mutual Street	East	Dundas Street East and a point 20 metres south	2	Zipcar
