

CITY OF TORONTO

BY-LAW 1417-2017

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Fort Rouille Street.

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

| (From Column 1 Highway) | (From Column 2 Side) | (From Column 3 Between) | (From Column 4 Prohibited Times and/or Days) |
|-------------------------|----------------------|--|--|
| Fort Rouille Street | East | Springhurst Avenue and a point 30.5 metres south | Anytime |
| Fort Rouille Street | West | Springhurst Avenue and a point 36.5 metres south | Anytime |

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

| (In Column 1 Highway) | (In Column 2 Side) | (In Column 3 Between) | (In Column 4 Prohibited Times and/or Days) |
|-----------------------|--------------------|--|--|
| Fort Rouille Street | West | The south end of Fort Rouille Street and a point 47.5 metres south of Springhurst Avenue | Anytime |

C. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

| (From Column 1 Highway) | (From Column 2 Side) | (From Column 3 Between) | (From Column 4 Time and/or Days) | (From Column 5 Maximum Period Permitted) |

| Fort Rouille Street | East | A point 30.5 metres south of Springhurst Avenue and the south end of Fort Rouille Street | 8:00 a.m. to 6:00 p.m. | 1 hour |

- D. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

| (In Column 1 Highway) | (In Column 2 Side) | (In Column 3 Between) | (In Column 4 Time and/or Days) | (In Column 5 Maximum Period Permitted) |
|-----------------------|--------------------|--|--------------------------------|--|
| Fort Rouille Street | East | The south end of Fort Rouille Street and a point 43.5 metres south of Springhurst Avenue | 8:00 a.m. to 6:00 p.m. | 1 hour |
| Fort Rouille Street | West | A point 38.5 metres south of Springhurst Avenue and a point 9 metres further south | 8:00 a.m. to 6:00 pm. | 1 hour |

- E. By deleting from Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

| (From Column 1 Highway) | (From Column 2 Side) | (From Column 3 Between) | (From Column 4 Prohibited Times and/or Days) |
|-------------------------|----------------------|--|--|
| Fort Rouille Street | East | Springhurst Avenue and a point 30.5 metres south | Anytime |
