BY-LAW 1419-2017

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Balliol Street, Davisville Avenue and Mount Pleasant Road.

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Mount Pleasant Road	East	A point 11 metres south of Davisville Avenue (east intersection) and a point 12.8 metres further south	Anytime
Mount Pleasant Road	East	Davisville Avenue (east intersection) and a point 48 metres south	Anytime
Mount Pleasant Road (east branch)	East	A point 15 metres north of Balliol Street and a point 36 metres further north	7:00 a.m. to 6:00 p.m., Mon. to Fri.

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Mount Pleasant Road (east branch)	East	Balliol Street and Davisville Avenue	7:00 a.m. to 6:00 p.m., Mon. to Fri.

- C. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

Davisville Avenue	South	Mount Pleasant Road and a point 20 metres east	Anytime
Mount Pleasant Road	West	Balliol Street and Davisville Avenue	Anytime

- D. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Balliol Street	North	Mount Pleasant Road (west intersection) and a point 36 metres east	Anytime
Davisville Avenue	North	A point 32 metres east of Mount Pleasant Road (west intersection) and a point 30 metres further east	Anytime
Davisville Avenue	South	Mount Pleasant Road (west intersection) and a point 64 metres east	Anytime
Mount Pleasant Road (east branch)	West	Balliol Street and Davisville Avenue	Anytime

- E. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time and/or Days)	(From Column 5 Maximum Period Permitted)
Balliol Street	North	Mount Pleasant Road (west intersection) and Forsyth Road	10:00 a.m. to 6:00 p.m., Mon. to Fri.	1 hour

- F. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time and/or Days)	(In Column 5 Maximum Period Permitted)
Balliol Street	North	A point 36 metres east of Mount Pleasant Road (west intersection) and Forsyth Road	10:00 a.m. to 6:00 p.m., Mon. to Fri.	1 hour

- G. By deleting from Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Davisville Avenue	South	A point 20 metres east of Mount Pleasant Road and a point 44 metres further east	Anytime
Lane, first public, north of Balliol Street and east of the east branch of Mount Pleasant Road	Both	The east branch of Mount Pleasant Road and a point 39 metres east	Anytime
