## BY-LAW 1447-2017

To amend City of Toronto Municipal Code Chapter 441, Fees and Charges, to add fees for business improvement area street event applications and permits.

Whereas at its meeting of December 5, 6, 7 and 8, 2017, City Council authorized the introduction of fees for business improvement area street event applications and permits; and

Whereas it is necessary to amend Municipal Code Chapter 441, Fees and Charges to include the fees for the business improvement area street events;

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 441, Fees and Charges, is amended by adding the following fees to Appendix C - Schedule 2, Transportation Services:
