BY-LAW 1466-2017

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Strathmore Boulevard.

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule V (Stands for Taxicabs) in § 950-1304, the following in alphabetical order by street name:

| (From Column 1 Highway) | (From Column 2 Side) | (From Column 3 Location) | (From Column 4 Number of Taxicabs) | (From Column 5 Times and/or Days) |
|-------------------------|----------------------|---|------------------------------------|-----------------------------------|
| Strathmore Boulevard | South | A point 9 metres east of Woodbine Avenue and a point 44 metres further east | 7 | Anytime |

B. By inserting in Schedule V (Stands for Taxicabs) in § 950-1304, the following in alphabetical order by street name:

| (In Column 1 Highway) | (In Column 2 Side) | (In Column 3 Location) | (In Column 4 Number of Taxicabs) | (In Column 5 Times and/or Days) |
|-----------------------|--------------------|--|----------------------------------|---------------------------------|
| Strathmore Boulevard | South | A point 38 metres east of Woodbine Avenue and a point 16 metres further east | 3 | Anytime |
| Strathmore Boulevard | South | A point 86 metres east of Woodbine Avenue and a point 22 metres further east | 4 | Anytime |

- C. By inserting in Schedule VII (Passenger Loading Zones) in § 950-1306, the following in alphabetical order by street name:

- D. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

| (From Column 1 Highway) | (From Column 2 Side) | (From Column 3 Between) | (From Column 4 Prohibited Times and/or Days) |
|-------------------------|----------------------|---|---|
| Strathmore Boulevard | North | Coxwell Avenue and a point 162 metres east of Woodmount Avenue | Anytime |
| Strathmore Boulevard | South | A point 81 metres east of Woodbine Avenue and Cedarvale Avenue | Anytime |
| Strathmore Boulevard | South | Woodbine Avenue and a point 33.7 metres west of Woodbine Avenue | 9:00 a.m. to 11:00 a.m., Wed. only, from Apr. 1 to Nov. 30, inclusive |

- E. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

- F. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

|-------------------------|----------------------|--|--|
| Strathmore Boulevard | South | A point 44 metres east of Woodbine Avenue and a point 81 metres further east | Anytime |

- G. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

| (In Column 1 Highway) | (In Column 2 Side) | (In Column 3 Between) | (In Column 4 Prohibited Times and/or Days) |
|-----------------------|--------------------|--|--|
| Strathmore Boulevard | North | Woodbine Avenue and a point 26 metres west | Anytime |
| Strathmore Boulevard | South | A point 54 metres east of Woodbine Avenue and a point 32 metres further east | Anytime |
| Strathmore Boulevard | South | Woodbine Avenue and a point 27 metres west | Anytime |

- H. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

| (From Column 1 Highway) | (From Column 2 Side) | (From Column 3 Between) | (From Column 4 Time and/or Days) | (From Column 5 Maximum Period Permitted) |
|-------------------------|----------------------|--|--------------------------------------|--|
| Strathmore Boulevard | South | A point 76.2 metres east of Coxwell Avenue and a point 162.3 metres east of Woodmount Avenue | 8:00 a.m. to 6:00 p.m., Mon. to Fri. | 1 hour |

- I. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

| (In Column 1 Highway) | (In Column 2 Side) | (In Column 3 Between) | (In Column 4 Time and/or Days) | (In Column 5 Maximum Period Permitted) |
|-----------------------|--------------------|--|---|--|
| Strathmore Boulevard | South | A point 76 metres east of Coxwell Avenue and a point 27 metres west of Woodbine Avenue | 8:00 a.m. to 6:00 p.m., Mon. to Fri. | 1 hour |
