BY-LAW 200-2018

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Malcolm Road.

The North York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By inserting in Schedule VII (Passenger Loading Zones) in § 950-1306, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Location)	(In Column 4 Times and/or Days)
Malcolm Road	Southwest	A point 22 metres west of Millwood Road and a point 14 metres further west	Anytime

B. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Malcolm Road	Northeast	Adjacent to Presteign Heights School	8:00 a.m. to 6:00 p.m., Mon. to Fri.

C. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Malcom Road	Northeast	Randolph Road and a point 55.4 metres west of Millwood Road	8:00 a.m. to 6:00 p.m., Mon. to Sat.

D. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Malcolm Road	Northeast	Millwood Road and a point 55.4 metres west	Anytime
Malcolm Road	Southwest	Millwood Road and a point 22 metres west	Anytime
Malcolm Road	Southwest	A point 36 metres west of Millwood Road and a point 7.3 metres further west	Anytime

E. By inserting in Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Malcolm Road	Southwest	A point 22 metres west of Millwood Road and a point 14 metres further west	Anytime

F. By deleting from Schedule XVIII (One-Way Highways) in § 950-1317, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Between)	(From Column 3 Times and/or Days)	(From Column 4 Direction)
Malcolm Road	Millwood Road and a point 66 metres west	Anytime	Northwestbound

G. By inserting in Schedule XVIII (One-Way Highways) in § 950-1317, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Times and/or Days)	(In Column 4 Direction)
Malcolm Road	Millwood Road and a point 40 metres west	Anytime	Northwestbound
