BY-LAW 230-2018

To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Argyle Street, Delaware Avenue, Grace Street, Grenadier Road, Iona Avenue, Lamb Avenue, Logan Avenue, Perth Avenue, Richmond Street West, Shudell Avenue, Tranby Avenue and Wellington Street West.

The Toronto and East York Community Council enacts:

- 1. Municipal Code Chapter 903, Parking for Persons with Disabilities, is amended as follows:
- A. By deleting from Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:
