BY-LAW 233-2018

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting York Street.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule V (Stands For Taxicabs) in § 950-1304, the following in alphabetical order by street name:

| (From Column 1 Highway) | (From Column 2 Side) | (From Column 3 Location) | (From Column 4 Number of Taxicabs) | (From Column 5 Times and/or Days) |
|-------------------------|----------------------|--|------------------------------------|---|
| York Street | West | Immediately north of Front Street West | 6 | Anytime, except 7:30 a.m. to 9:30 a.m. and 3:30 p.m. to 6:30 p.m. |

B. By inserting in Schedule V (Stands For Taxicabs) in § 950-1304, the following in alphabetical order by street name:

| (In Column 1 Highway) | (In Column 2 Side) | (In Column 3 Location) | (In Column 4 Number of Taxicabs) | (In Column 5 Times and/or Days) |
|-----------------------|--------------------|------------------------------------|----------------------------------|---------------------------------|
| York Street | West | Front Street West and Heenan Place | 5 | Anytime |

C. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

| (From Column 1 Highway) | (From Column 2 Side) | (From Column 3 Between) | (From Column 4 Prohibited Times and/or Days) |
|-------------------------|----------------------|---|--|
| York Street | West | Front Street West and a point 47 metres south of King Street West | Anytime |

- D. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

| (In Column 1 Highway) | (In Column 2 Side) | (In Column 3 Between) | (In Column 4 Prohibited Times and/or Days) |
|-----------------------|--------------------|--|--|
| York Street | West | Wellington Street West and a point 47 metres south of King Street West | Anytime |

- E. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

| (From Column 1 Highway) | (From Column 2 Side) | (From Column 3 Between) | (From Column 4 Prohibited Times and/or Days) |
|-------------------------|----------------------|---|---|
| York Street | West | Front Street West and a point 30.5 metres south of Richmond Street West | 7:00 a.m. to 9:30 a.m. and 3:30 p.m. to 6:30 p.m., Mon. to Fri., except public holidays |

- F. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

| (In Column 1 Highway) | (In Column 2 Side) | (In Column 3 Between) | (In Column 4 Prohibited Times and/or Days) |
|-----------------------|--------------------|--|---|
| York Street | West | Wellington Street West and a point 30.5 metres south of Richmond Street West | 7:00 a.m. to 9:30 a.m. and 3:30 p.m. to 6:30 p.m., Mon. to Fri., except public holidays |
