BY-LAW 250-2018

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Wychwood Avenue.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Wychwood Avenue	East	St. Clair Avenue West and Alcina Avenue	Each Thu., Apr.1 to Nov. 30, inclusive

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Wychwood Avenue	East	Ellsworth Avenue and Alcina Avenue	Each Thurs. Apr. 1 to Nov. 30, inclusive
Wychwood Avenue	East	St. Clair Avenue West and a point 15 metres south	Anytime

C. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time and/or Days)	(From Column 5 Maximum Period Permitted)
Wychwood Avenue	East	A point 30.5 metres south of St. Clair Avenue West (west intersection) and Ellsworth Avenue	7:30 a.m. to 9:30 a.m., 4:00 p.m. to 6:00 p.m., Mon. to Fri.	10 mins.

Wychwood Avenue	East	A point 15 metres south of St. Clair Avenue West (west intersection) and a point 22 metres further south	7:30 a.m. to 9:30 a.m., 4:00 p.m. to 6:00 p.m., Mon. to Fri.	10 mins.
