BY-LAW 251-2018

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Stephanie Street.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By inserting in Schedule VI (Commercial Loading Zones) in § 950-1305, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Location)	(In Column 4 Times and/or Days)
Stephanie Street	North	A point 33.5 metres west of McCaul Street and a point 15 metres further west	Anytime

B. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Stephanie Street	North	McCaul Street and John Street	8:00 a.m. to 6:00 p.m., Mon. to Sat.
Stephanie Street	South	John Street and McCaul Street	Anytime

C. By inserting in Schedule XIII (No Parking) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Stephanie Street	North	John Street and a point 48.5 metres west of McCaul Street	8:00 a.m. to 6:00 p.m., Mon. to Sat.

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Stephanie Street	South	John Street and St. Patrick Square	Anytime

D. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Stephanie Street	North	McCaul Street and a point 33.5 metres west	Anytime
Stephanie Street	South	St. Patrick Square and McCaul Street	Anytime

2. This By-law shall be effective commencing March 1, 2018.
