CITY OF TORONTO

BY-LAW 403-2018

To amend City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to include the new Yonge and St. Clair Business Improvement Area and to establish a Board of Management for the Yonge and St. Clair Business Improvement Area.

Whereas Council, by the adoption of By-law 105-2018, authorized the designation of the area along Yonge Street bounded by Woodlawn Avenue to the south and Heath Street to the north, and the area along St. Clair Avenue from Avoca Avenue to the east and Avenue Road to the west, as a business improvement area under Municipal Code Chapter 19, Business Improvement Areas; and

Whereas Toronto and East York Community Council has established a board of management for the Yonge and St. Clair Business Improvement Area, and appointed members to the Yonge and St. Clair Business Improvement Area Board of Management for a term expiring on November 30, 2018, or as soon thereafter as successors are appointed; and

Whereas Schedule A of Municipal Code Chapter 19, Business Improvement Areas, must be amended to include the new Yonge and St. Clair Business Improvement Area Board of Management;

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 19, Business Improvement Areas, is amended as follows:
 - (1) The table in Schedule A, Boards of Management is amended by adding the new Yonge and St. Clair Board of Management as set out in Schedule A attached; and
 - (2) Schedule A, Maps is amended by adding the attached maps of the Yonge and St. Clair Business Improvement Area.
2. A Board of Management for the Yonge and St. Clair Business Improvement Area is established.

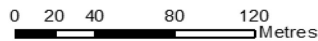
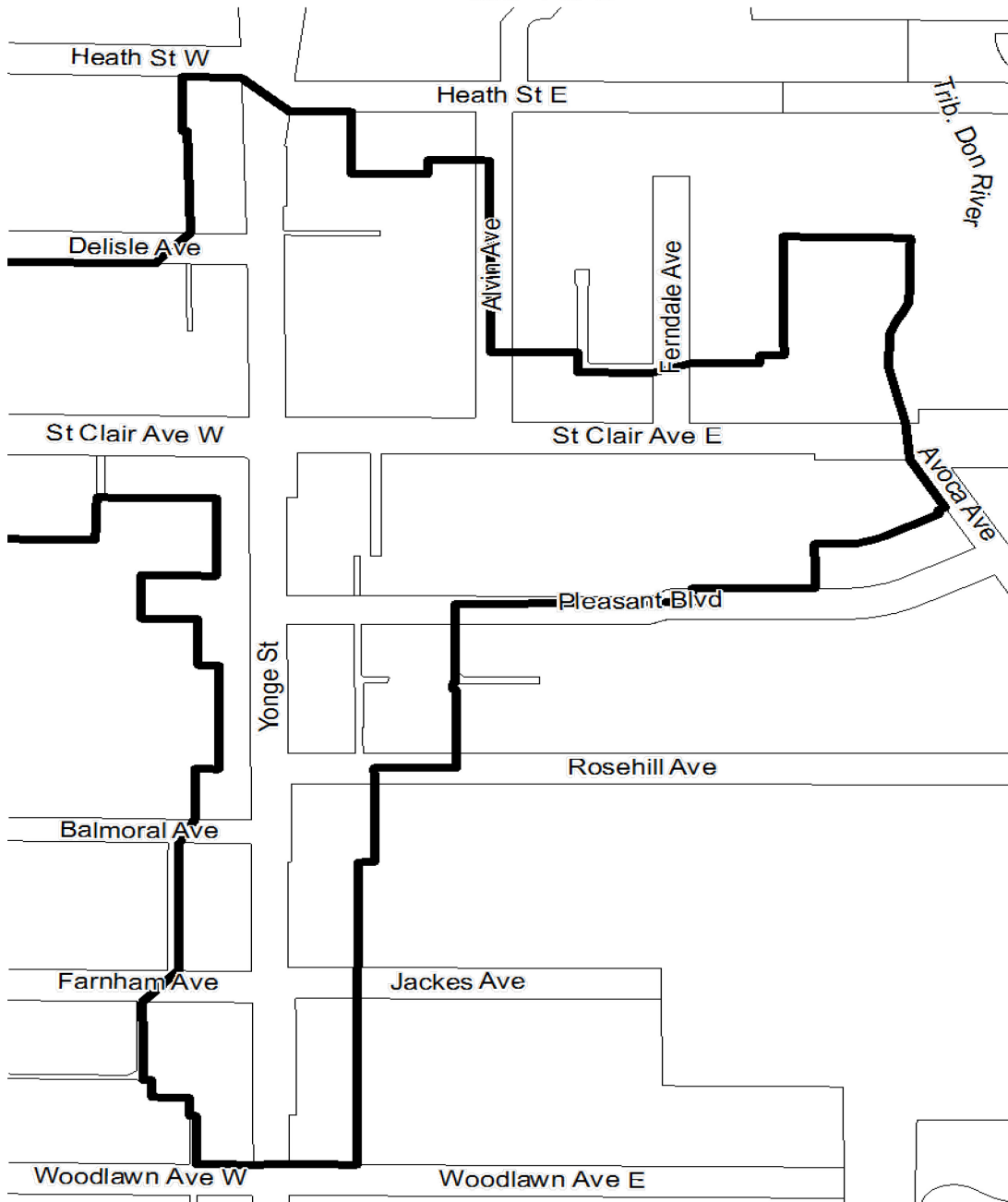

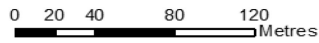
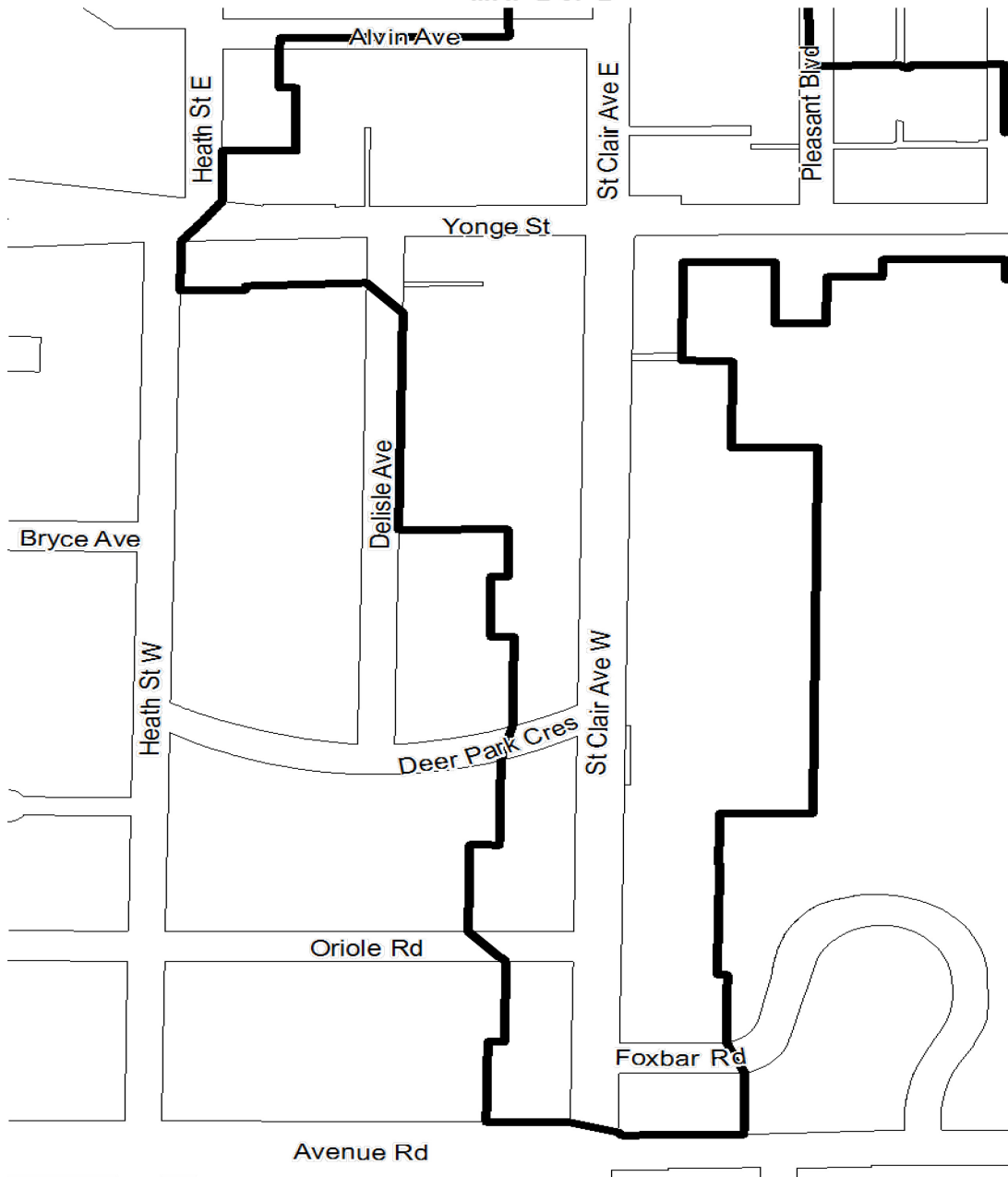
