**CITY OF TORONTO**

**BY-LAW 430-2018**

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Dalhousie Street and Shuter Street.**

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

| (From Column 1 Highway) | (From Column 2 Side) | (From Column 3 Between)   | (From Column 4 Prohibited Times and/or Days) |
|-------------------------|----------------------|---|--|
| Dalhousie Street        | West                 | A point 48.8 metres north of Shuter Street and Dundas Street East | Anytime                                      |
| Dalhousie Street        | West                 | Queen Street East and Shuter Street                               | Anytime                                      |

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

| (In Column 1 Highway) | (In Column 2 Side) | (In Column 3 Between)                    | (In Column 4 Prohibited Times and/or Days) |
|-----------------------|--------------------|--|--|
| Dalhousie Street      | West               | Queen Street East and Dundas Street East | Anytime                                    |

C. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

| (From Column 1 Highway) | (From Column 2 Side) | (From Column 3 Between)                       | (From Column 4 Prohibited Times and/or Days) |
|-------------------------|----------------------|---|--|
| Dalhousie Street        | Both                 | Shuter Street and a point 48.8 metres north   | Anytime                                      |
| Shuter Street           | Both                 | Dalhousie Street and a point 44.6 metres east | Anytime                                      |

D. By deleting from Schedule XVIII (One-Way Highways) in § 950-1317, the following in alphabetical order by street name:

| (From<br>Column 1<br>Highway) | (From<br>Column 2<br>Between)                  | (From<br>Column 3<br>Times and/or Days) | (From<br>Column 4<br>Direction) |
|-------------------------------|--|---|---------------------------------|
| Dalhousie Street              | Shuter Street and a point<br>34.8 metres north | Anytime                                 | Northbound                      |
