## CITY OF TORONTO

### BY-LAW 718-2018

#### **To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Gore Street, Gore Vale Avenue, Hazelwood Avenue, Highfield Road, Lappin Avenue, Major Street, Prust Avenue, Roxton Road, Stadium Road and Wildwood Crescent.**

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 903, Parking for Persons with Disabilities, is amended as follows:
  - A. By deleting from Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time or Days)
Gore Street	North	A point 64 metres west of Clinton Street and a point 5.5 metres further west	Anytime
Hazelwood Avenue	South	A point 118 metres west of Jones Avenue and a point 5.5 metres further west	Anytime
Major Street	East	A point 57 metres north of Ulster Street and a point 5.5 metres further north	Anytime
Wildwood Crescent	South	A point 132 metres east of Kingsmount Park Road and a point 5.5 metres further east	Anytime

- B. By inserting in Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time or Days)
Gore Vale Avenue	East	A point 210.1 metres south of Dundas Street West and a point 5.5 metres further south	Anytime

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time or Days)
Highfield Road	East	A point 83 metres north of Gerrard Street East and a point 5.5 metres further north	From Dec. 1 of one year to Mar. 31 of the next following year, inclusive and from the 1 <sup>st</sup> day to the 15 <sup>th</sup> day of each month from Apr. 1 to Nov. 30, inclusive
Highfield Road	West	A point 83.5 metres north of Gerrard Street East and a point 5.5 metres further north	From the 16 <sup>th</sup> day to the last day of each month from Apr. 1 to Nov. 30, inclusive
Lappin Avenue	North	A point 15 metres east of Emerson Avenue and a point 5.5 metres further east	Anytime
Major Street	East	A point 17.5 metres north of Loui Laki Lane and a point 7 metres further north	Anytime
Prust Avenue	West	A point 63.5 metres north of Gerrard Street East and a point 5.5 metres further north	Anytime
Roxton Road	West	A point 141.5 metres south of College Street and a point 5.5 metres further south	Anytime
Stadium Road	West	A point 14.5 metres north of Queens Quay West and a point 5.5 metres further north	Anytime
