CITY OF TORONTO

BY-LAW 929-2018

To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Glebeholme Boulevard, Iona Avenue, Kippendavie Avenue, Lawlor Avenue, Montrose Avenue, Paisley Avenue, Saint Annes Road, Sunnyside Avenue and Wolverleigh Boulevard.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 903, Parking for Persons with Disabilities, is amended as follows:
 - A. By deleting from Schedule II (Designated On-Street Parking Permit Holders), the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time or Days)
Kippendavie Avenue	West	A point 70.5 metres north of Buller Avenue and a point 5.5 metres further north	Anytime
Lawlor Avenue	West	A point 99 metres north of Kingston Road and a point 5.5 metres further north	Anytime

- B. By inserting in Schedule II (Designated On-Street Parking Permit Holders), the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time or Days)
Glebeholme Boulevard	South	A point 20 metres west of Linnsmore Crescent and a point 5.5 metres further west	Anytime
Iona Avenue	East	A point 50 metres north of Oakcrest Avenue and a point 5.5 metres further north	Anytime
Lawlor Avenue	West	A point 82.5 metres north of Kingston Road and a point 5.5 metres further north	Anytime

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time or Days)
Montrose Avenue	East	A point 133.5 metres north of Dundas Street West and a point 5.5 metres further north	Anytime from the 1 st day to the 15 th day of each month from Apr. 1 to Nov. 30, inclusive
Montrose Avenue	West	A point 131.2 metres north of Dundas Street West and a point 5.5 metres further north	Anytime from Dec. 1 of one year to mar. 31 of the next following year, inclusive, and from the 16 th day to the last day of each month from Apr. 1 to Nov. 30, inclusive
Paisley Avenue	North	A point 62.5 metres west of Logan Avenue and a point 5.5 metres further west	Anytime
St. Annes Road	North	A point 23 metres west of Coolmine Road and a point 5.5 metres further west	Anytime from Dec. 1 of one year to Mar. 31 of the next following year, inclusive and from the 1 st day to the 15 th day of each month from Apr. 1 to Nov. 30, inclusive
St. Annes Road	South	A point 20 metres west of Coolmine Road and a point 5.5 metres further west	Anytime from the 16 th day to the last day of each month from Apr. 1 to Nov. 30, inclusive
Sunnyside Avenue	East	A point 22.5 metres north of Grenadier Road and a point 5.5 metres further north	Anytime
Wolverleigh Boulevard	South	A point 75 metres east of Glebemount Avenue and a point 5.5 metres further east	Anytime
