## CITY OF TORONTO

### BY-LAW 1132-2018

**To amend former City of Toronto Municipal Code Chapter 25, Community and Recreation Centres, City of Toronto Municipal Code Chapter 12, Balmy Beach Park Board of Management, Chapter 23, Civic Theatres, and Chapter 636, Public Squares, to reflect the new Community Council Boundaries effective December 1, 2018.**

Whereas by the adoption of Executive Committee Item EX18.2, Council confirmed at its meeting on November 8 and 9, 2016 that its composition shall remain as one member of Council per ward plus the Mayor based on the total number of wards established, which resulted in a composition of 47 Councillors plus the Mayor; and

Whereas the Ontario Municipal Board issued a decision and order in case number MM170033 dated December 15, 2017 confirming that the number of wards in the City of Toronto shall be 47; and

Whereas no outstanding appeals remain and the appeal process for the City's ward boundary by-laws has concluded; and

Whereas effective December 1, 2018, City Council will be composed of 47 Councillors representing 47 wards plus the mayor; and

Whereas the increase to 47 Councillors representing 47 wards has resulted in the need to make housekeeping amendments to various City by-laws to adjust ward specific references to align to the revised ward boundaries, effective December 1, 2018, as adopted in Item EX35.2; and

Whereas Schedule A refers to various By-laws and Municipal Code Chapters that must be amended to reflect the revised ward boundaries of the wards in which the Arena Boards, Community Centres and other Boards are located;

The Council of the City of Toronto enacts:

1. The references to the existing 44 wards shall be replaced by references to the 47 wards in the various By-laws and Municipal Code Chapters as described in Schedule A to this by-law.
2. Schedule A attached forms part of this by-law.
3. This by-law comes into force on December 1, 2018.
