BY-LAW 338-2019

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, to correct an error with respect to the reduction of the speed limit from 40 km/h to 30 km/h on a portion of Walmer Road.

Whereas Toronto and East York Community Council, at its special meeting held on June 22, 2015, adopted as amended, Item TE8.1 entitled "30 km/h Speed Limit on Local Roads in the Toronto and East York Community Council Area" and, in so doing, directed that the speed limit on local roads with 40 km/h speed limits in the Toronto and East York Community Council area, excluding those roads that bound more than one Community Council area, be reduced to 30 km/h; and

Whereas Toronto and East York Community Council, on November 10, 2015, enacted By-law 1261-2015 to reduce the speed limit from 40 km/h to 30 km/h on local roads in then Ward 21; and

Whereas By-law 1261-2015 reduced the speed limit from 40 km/h to 30 km/h on Walmer Road, between Davenport Road and Austin Terrace; and

Whereas Walmer Road between Davenport Road and Austin Terrace is classified as a minor arterial road and not a local road; and

Whereas the speed limit should not have been reduced to 30 km/h on the aforementioned subject portion of Walmer Road; and

Whereas under Section 169-5.2 of Chapter 169, Officials, City, of The City of Toronto Municipal Code, the City Solicitor, in consultation with the City Clerk, may submit bills directly to make technical amendments to The City of Toronto Municipal Code and other by-laws to correct technical errors;

The Toronto and East York Community Council enacts:

- 1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
- A. By deleting from Schedule XXXV (Speed Limits on Public Highways) in § 950-1334 the following in alphabetical order by street name:
