CITY OF TORONTO

BY-LAW 448-2019

To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Chatham Avenue, Gainsborough Road, Gilbert Avenue, Harcourt Avenue, Indian Road Crescent, Milverton Boulevard, Nairn Avenue, O'Hara Avenue, Perth Avenue, Seymour Avenue and Wolfrey Avenue.

The Toronto and East York Community Council enacts:

- 1. Municipal Code Chapter 903, Parking for Persons with Disabilities, is amended as follows:
- A. By deleting from Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:
