CITY OF TORONTO

BY-LAW 633-2019

To establish a Board of Management for the new Little Portugal on Dundas Business Improvement Area, to dissolve the Boards of Management of the Dundas West Business Improvement Area and the Little Portugal Business Improvement Area and amend City of Toronto Municipal Code Chapter 19, Business Improvement Areas.

Whereas Council, by the adoption of By-law 524-2019, designated an area that includes the existing areas of both the Dundas West Business Improvement Area and the Little Portugal Business Improvement Area, as a business improvement area under Municipal Code Chapter 19, Business Improvement Areas; and

Whereas Toronto and East York Community Council has established a board of management for the Little Portugal on Dundas Business Improvement Area, and appointed members to the Little Portugal on Dundas Business Improvement Area Board of Management for a term expiring on November 30, 2022, or as soon thereafter as successors are appointed; and

Whereas Toronto and East York Community Council has dissolved the board of management of the Dundas West Business Improvement Area and the board of management of the Little Portugal Business Improvement Area; and

Whereas Schedule A of Municipal Code Chapter 19, Business Improvement Areas, must be amended to include the new Little Portugal on Dundas Business Improvement Area Board of Management, and to delete the Boards of Management of the Dundas West Business Improvement Area and the Little Portugal Business Improvement Area;

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 19, Business Improvement Areas, is amended as follows:
 - (1) The table in Schedule A, Boards of Management, is amended by adding the new Little Portugal on Dundas Business Improvement Area Board of Management as set out in Schedule A attached;
 - (2) The table in Schedule A, Boards of Management, is amended by removing the Dundas West Business Improvement Area Board of Management and the Little Portugal Business Improvement Area Board of Management;
 - (3) Schedule A, Maps, is amended by adding the attached maps of the Little Portugal on Dundas Business Improvement Area;
 - (4) Schedule A, Maps, is amended by removing the maps of the Dundas West Business Improvement Area Board of Management and the Little Portugal Business Improvement Area Board of Management.

2. A Board of Management for the Little Portugal on Dundas Business Improvement Area is established.
3. By-law 1145-2007, being the designating by-law of the Little Portugal Business Improvement Area, and By-law 835-2006, being the designating by-law for the Dundas West Business Improvement Area, are repealed.
4. The Boards of Management of the Dundas West Business Improvement Area and the Little Portugal Business Improvement Area are dissolved.

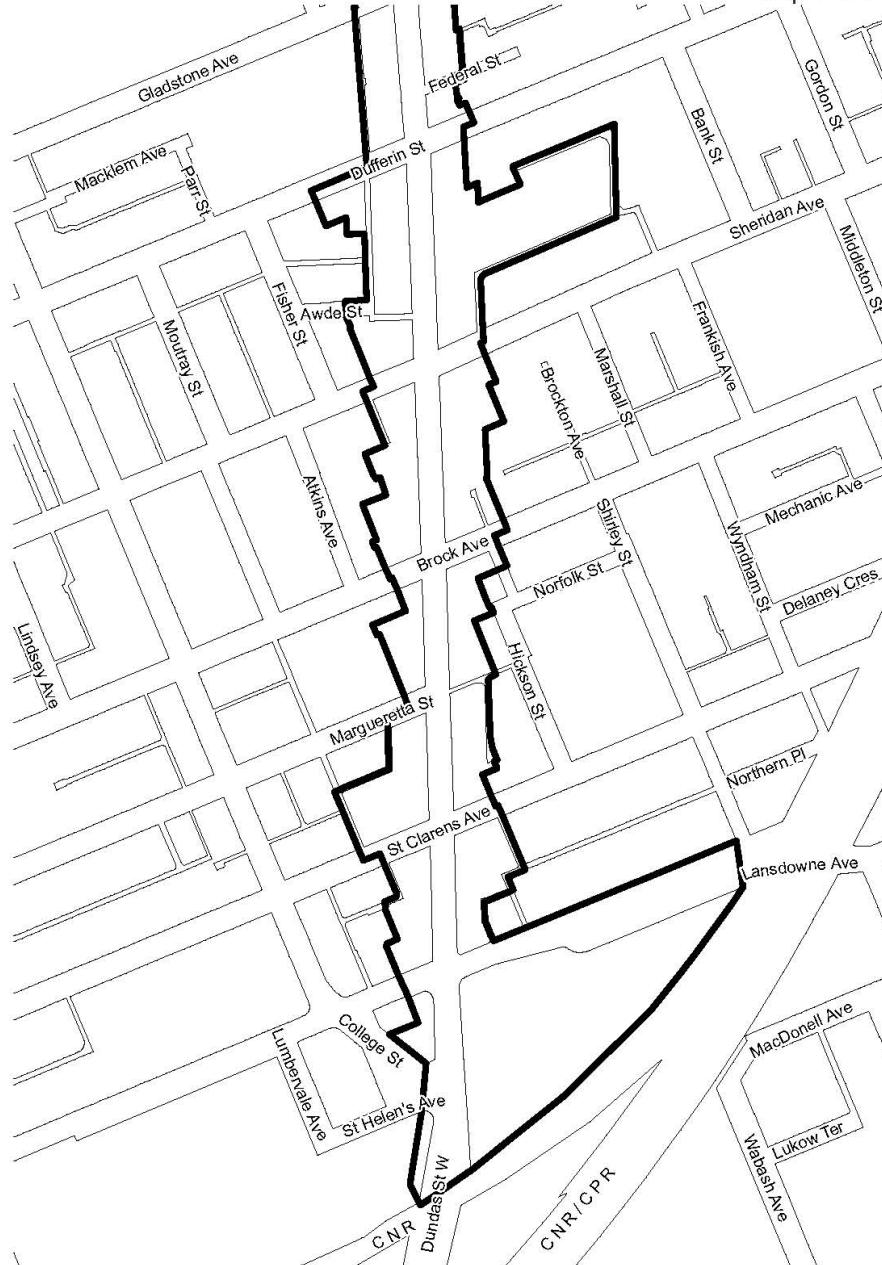

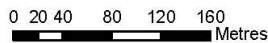

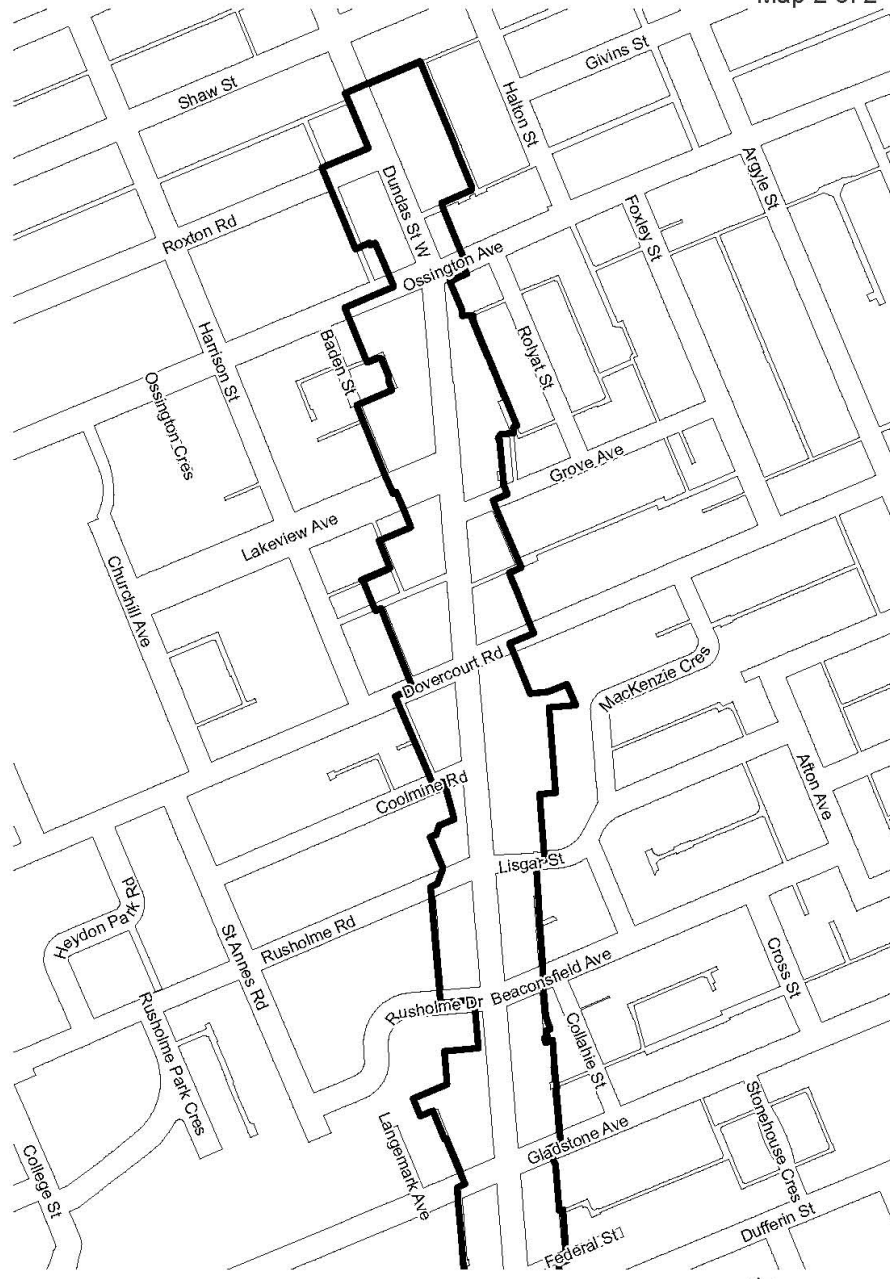
 Little Portugal On Dundas BIA




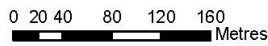
