BY-LAW 937 -2019

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Freshmeadow Drive.

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Freshmeadow Drive	North	Townsend Road and a point opposite the westerly limit of Applegate Crescent (west intersection)	8:00 a.m. to 4:00 p.m., Mon. to Fri.

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Freshmeadow Drive	South	A point 164.7 metres east of Don Mills Road and a point 369.1 metres east of Don Mills Road	9:00 a.m. to 3:00 p.m. and 6:00 p.m. of one day to 7:00 a.m. of the next following day, Mon. to Fri.; Anytime Sat. and Sun.

C. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Freshmeadow Drive	South	A point 164.7 metres east of Don Mills Road and a point 369.1 metres east of Don Mills Road	8:00 a.m. to 6:00 p.m., Mon. to Fri.

D. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Freshmeadow Drive	North	Townsend Road and a point opposite the westerly limit of Applegate Crescent (west intersection)	8:00 a.m. to 4:00 p.m., Mon. to Fri.

E. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time and/or Days)	(In Column 5 Maximum Period Permitted)
Freshmeadow Drive	South	A point 164.7 metres east of Don Mills Road and a point 369.1 metres east of Don Mills Road	7:00 a.m. to 9:00 a.m. and 3:00 p.m. to 6:00 p.m., Mon. to Fri.	10 mins.
