BY-LAW 1161-2019

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, and City of Toronto Municipal Code Chapter 610, Penalties, Administration of, with respect to the penalty amounts for various stopping and parking violations.

The Council of the City of Toronto enacts:

- 1. Municipal Code Chapter 950, Traffic and Parking, is amended by inserting a new Subsection (1.1) in § 950-400B as follows:
 - (1.1) On or over a boulevard unless stopping is authorized under any other Municipal Code chapter or by-law.
- 2. Municipal Code Chapter 610, Penalties, Administration of, is amended as follows:
