CITY OF TORONTO

BY-LAW 1305-2019

To amend former City of Toronto Zoning By-law 438-86, as amended, with respect to the lands municipally known in the year 2019 as 185 - 450 Commissioners Street (north side); 101 - 495 Commissioners Street (south side); 625 - 811 Lake Shore Boulevard East (south side); 17, 21, 23, 29, 35, 41, 75 Basin Street; 185 Villiers Street; 115 Saulter Street; 120 Bouchette Street (also known as "McCleary District, Media City and Turning Basin District"), being a portion of the Port Lands in the City of Toronto.

Whereas Council of the City of Toronto has the authority pursuant to Section 34 of the Planning Act, R.S.O. 1990, c. P. 13, as amended, to pass this by-law; and

Whereas Council of the City of Toronto has provided adequate information to the public and has held at least one public meeting in accordance with the Planning Act;

The Council of the City of Toronto enacts:

- 1. District Maps 52G-311, 52G-312, 52G-322, and 52G-323 of By-law 438-86 are amended by designating those lands delineated by heavy lines on Map A, attached to and forming part of this by-law, to the "I2 D2" zone.
- 2. Section 12(1) of By-law 438-86 is amended by adding the following Exception 493:
 - (a) on the lands outlined by heavy lines on Map B, attached to and forming part of this by-law, no person shall use any land or erect or use any building or structure that does not comply with the following:
 - (i) Section 9(1)(f) of Zoning By-law 438-86, as amended, is replaced such that the uses listed in subsection (A) below, and accessory uses thereto, are permitted:

- (ii) Despite Clause 2(a)(i), the lands at 400 Commissioners Street may contain a waste transfer station;
- (iii) Despite Clause 2(a)(i), the lands at 475 Commissioners Street may contain a courier service;

- (iv) Despite Clause 2(a)(i), the lands at 829 Lake Shore Boulevard East may contain an automobile service station and a retail store;
- (v) Despite Clause 2(a)(i), the lands at 865 Lake Shore Boulevard East and 115 Saulter Street may contain a shipping, trans-shipping or distribution depot;
- (vi) Despite Clause 2(a)(i), the lands at 29 Basin Street, 35 Basin Street and 41 Basin Street may contain an open storage of raw materials yard;
- (vii) Despite Clause 2(a)(i), the lands at 29 Basin Street may contain an office; and
- (viii) If any of the uses listed in Clause 2(a)(i) correspond to defined terms set out in By-law 438-86, then such defined terms in By-law 438-86 shall apply.
