BY-LAW 1379-2019

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting
Christie Street (east roadway).**

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule VII (Passenger Loading Zones) in § 950-1306, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Location)	(From Column 4 Times and/or Days)
Christie Street (east roadway)	East	A point 66.5 metres north of Bloor Street West and a point 28 metres further north	Anytime

B. By inserting in Schedule VII (Passenger Loading Zones) in § 950-1306, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Location)	(In Column 4 Times and/or Days)
Christie Street (east roadway)	East	A point 75.5 metres north of Bloor Street West and a point 19 metres further north	Anytime

C. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Christie Street (east roadway)	East	A point 29 metres north of Bloor Street West and a point 37.5 metres further north	Anytime

D. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Christie Street (east roadway)	East	A point 29 metres north of Bloor Street West and a point 46.5 metres further north	Anytime

E. By deleting from Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Christie Street (east roadway)	East	A point 66.5 metres north of Bloor Street West and a point 28 metres further north	Anytime

F. By inserting in Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Christie Street (east roadway)	East	A point 75.5 metres north of Bloor Street West and a point 19 metres further north	Anytime
