## **CITY OF TORONTO**

## BY-LAW 1392-2019

## To amend Schedule A of City of Toronto Municipal Code Chapter 71, Financial Control, to include Solid Waste Management Services and to make further technical amendments necessitated by administrative changes.

Whereas at its meeting of July 23, 24, 25, 26, 27 and 30, 2018, City Council authorized the amendment of Section 21 of Schedule A of Municipal Code Chapter 71, Financial Control, to include Solid Waste Management Services, thereby authorizing the General Manager, Solid Waste Management Services, to negotiate and enter into agreements and participate in research initiatives or projects with post-secondary educational institutions, other municipalities or governmental agencies and non-profit organizations, subject to criteria already outlined in Section 21; and

Whereas §169-5.2B of Municipal Code Chapter 169, Officials, City, provides that the City Solicitor, in consultation with the City Clerk, may submit bills directly to Council to make technical amendments to the Municipal Code and other by-laws to correct technical errors, to update the by-laws to refer to the current statute, City official title, administrative unit and Municipal Code provision and to repeal by-laws of the former municipalities that have been superseded by provisions in the Municipal Code or as a result of an administrative reorganization; and

Whereas it is necessary to amend Section 21 of Schedule A of Municipal Code Chapter 71, to reflect Council's decision to include Solid Waste Management Services and also to make further technical amendments necessitated by administrative changes rendering "Toronto Water's Business Plan" obsolete;

The Council of the City of Toronto enacts:

1. Section 21 of Schedule A of Municipal Code Chapter 71, Financial Control, is deleted in its entirety and replaced with the following:

## 21. Toronto Water and Solid Waste Management Services Research Initiatives or Projects

Payments to post-secondary education institutions, other municipalities, government agencies and/or not for profit professional organizations in respect to the funding, participation or procurement of services related to research initiatives or projects which directly contribute to achieving the goals and objectives of Toronto Water or the goals and objectives of Solid Waste Management Services, as applicable, subject to the following criteria:

А.	The research initiative or project is of a scientific or technical nature utilizing specialized academic or professional expertise at competitive rates;
В.	Toronto Water's contribution or Solid Waste Management Services' contribution, as applicable, to each research initiative prior project does not exceed a value of \$500,000.00 (exclusive of taxes) per year; and
C.	An agreement is entered into among all participants involved in the research initiative or project on terms and conditions satisfactory to the City Solicitor.
