

CITY OF TORONTO

BY-LAW 1435-2019

To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Buller Avenue, Dundurn Crescent, Humberside Avenue, Kent Road, Nairn Avenue, Pape Avenue, Winona Drive.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 903, Parking for Persons with Disabilities, is amended as follows:
 - A. By deleting from Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time or Days)
Buller Avenue	North	A point 55 metres west of Kippendavie Avenue and a point 5.5 metres further west	Anytime
Kent Road	East	A point 82 metres north of Queen Street East and a point 5.5 metres further north	Anytime
Kent Road	West	A point 79 metres north of Queen Street East and a point 5.5 metres further north	Anytime
Pape Avenue	East	A point 78.5 metres south of Queen Street East and a point 5.5 metres further south	Anytime
Pape Avenue	West	A point 93 metres north of Eastern Avenue and a point 6 metres further north	Anytime

- B. By inserting in Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	In Column 4 Time or Days)
Dundurn Crescent	East	A point 26.6 metres south of Winona Drive (north intersection) and a point 5.5 metres further south	Anytime

Humberside Avenue	North	A point 91.5 metres west of Dundas Street West and a point 5.5 metres further west	Anytime
Humberside Avenue	North	A point 120.8 metres west of Dundas Street West and a point 5.5 metres further west	Anytime
Kent Road	East	A point 82 metres north of Queen Street East and a point 5.5 metres further north	From Dec. 1 of one year to Mar. 31 of the next following year, inclusive and from 1 st day to the 15 th day of each month from Apr. 1 to Nov. 30, inclusive
Kent Road	West	A point 79 metres north of Queen Street East and a point 5.5 metres further north	From the 16 th day to the last day of each month from Apr. 1 to Nov. 30, inclusive
Nairn Avenue	East	A point 21 metres north of Hope Street and a point 5.5 metres further north	From Dec. 1 of one year to Mar. 31 of the next following year, inclusive and from the 1 st day to the 15 th day of each month from Apr. 1 to Nov. 30, inclusive
Nairn Avenue	West	A point 20 metres north of Hope Street and a point 5.5 metres further north	From the 16 th day to the last day of each month from Apr. 1 to Nov. 30, inclusive
Winona Drive	East	A point 29.5 metres south of Earlsdale Avenue and a point 5.5 metres further south	From Dec. 1 of one year to Mar. 31 of the next following year, inclusive and from the 1 st day to the 15 th day of each month from Apr. 1 to Nov. 30, inclusive

Winona Drive	West	A point 33.5 metres south of Earlsdale Avenue and a point 5.5 metres further south	From the 16 th day to the last day of each month from Apr. 1 to Nov. 30, inclusive
