

CITY OF TORONTO

BY-LAW 1593-2019

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Manor Road East.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
 - A. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Manor Road East	South	A point 24 metres west of Servington Crescent (east intersection) and a point 32.5 metres further west	Anytime

- B. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

Manor Road East	South	A point 9 metres west of Servington Crescent (east intersection) and a point 15 metres further west	8:00 a.m. to 9:00 a.m., Mon. to Fri.	10 mins.
Manor Road East	South	A point 24 metres west of Servington Crescent (east intersection) and a point 52 metres west of Mount Pleasant Road	10:00 a.m. to 6:00 p.m.	1 hour
Manor Road East	South	Servington Crescent (west intersection) and a point 56.5 metres west of Servington Crescent (east intersection)	10:00 a.m. to 6:00 p.m.	1 hour
Manor Road East	South	Redpath Avenue and a point 56.5 metres west of Servington Crescent (east intersection)	8:00 a.m. to 10:00 a.m., Mon. to Fri.	10 mins.

D. By deleting from Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Manor Road East	Both	Mount Pleasant Road and a point 39 metres west	Anytime

E. By inserting in Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Manor Road East	Both	Mount Pleasant Road and a point 52 metres west	Anytime
