

CITY OF TORONTO

BY-LAW 1704-2019

To authorize the naming of a public street located in the block bounded by Dundas Street West, Dunbloor Road, Bloor Street West and Kipling Avenue as Jerry Howarth Drive.

Whereas pursuant to Section 27-18.4E(4) of City of Toronto Municipal Code Chapter 27, Council Procedures, Etobicoke York Community Council has the authority to pass a by-law naming the public street;

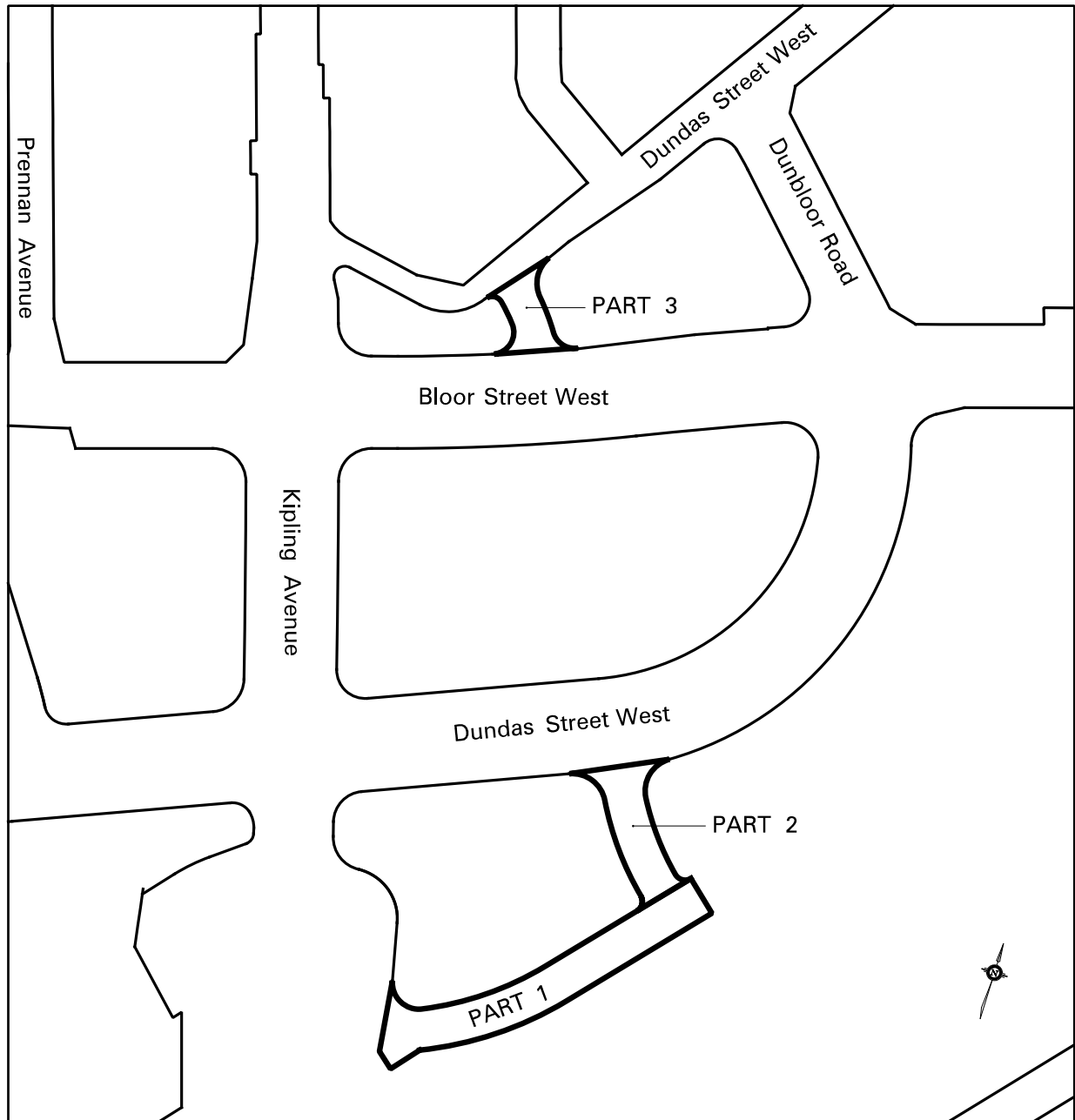
