## CITY OF TORONTO

### BY-LAW 172-2020

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, to correct a technical error with respect to the reduction of the speed limit from 40 km/h to 30 km/h on portions of Pape Avenue (former Ward 30, now Ward 14).**

Whereas Toronto and East York Community Council, at its special meeting held on June 22, 2015, adopted as amended, Item TE8.1 entitled "30 km/h Speed Limit on Local Roads in the Toronto and East York Community Council Area" and, in so doing, directed that the speed limit on local roads with 40 km/h speed limits in the Toronto and East York Community Council area, excluding those roads that bound more than one Community Council area, be reduced to 30 km/h; and

Whereas Toronto and East York Community Council, on November 10, 2015, enacted By-law 1262-2015 to reduce the speed limit from 40 km/h to 30 km/h on local roads in the then Ward 30; and

Whereas By-law 1262-2015 reduced the speed limit from 40 km/h to 30 km/h on Pape Avenue, between a point 63.3 metres south of Langley Avenue and Danforth Avenue; and

Whereas Pape Avenue, between Riverdale Avenue and Danforth Avenue, is classified as a minor arterial road and not a local road and, as such, the speed limit should not have been reduced to 30 km/h on the aforementioned segment of Pape Avenue; and

Whereas under Section 169-5.2B of Chapter 169, Officials, City, of The City of Toronto Municipal Code, the City Solicitor, in consultation with the City Clerk, may submit bills directly to make technical amendments to The City of Toronto Municipal Code and other by-laws to correct technical errors;

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
  - A. By deleting from Schedule XXXV (Speed Limits on Public Highways) in § 950-1334, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Between)	(From Column 3 Speed Limit (km/h))
Pape Avenue	A point 63.3 metres south of Langley Avenue and Danforth Avenue	30

B. By inserting in Schedule XXXV (Speed Limits on Public Highways) in § 950-1334, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Speed Limit (km/h))
Pape Avenue	A point 63.3 metres south of Langley Avenue and Riverdale Avenue	30
Pape Avenue	Riverdale Avenue and Danforth Avenue	40
