

**CITY OF TORONTO**

**BY-LAW 266-2020**

**To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Cayuga Avenue, Lapp Street.**

The Etobicoke York Community Council enacts:

1. Municipal Code Chapter 903, Parking for Persons with Disabilities, is amended as follows:

A. By deleting from Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

| (From<br>Column 1<br>Highway) | (From<br>Column 2<br>Side) | (From<br>Column 3<br>Between)  | (From<br>Column 4<br>Time or Days)   |
|-------------------------------|----------------------------|--|--|
| Lapp Street                   | East                       | A point 86.8 metres south of Northland Avenue and a point 5.5 metres further south | From the 1 <sup>st</sup> day to the 15 <sup>th</sup> day of each month from Apr. 1 to Nov. 30, inclusive   |
| Lapp Street                   | West                       | A point 82.5 metres south of Northland Avenue and a point 5.5 metres further south | From Dec. 1 of one year to Mar. 31 of the next following year, inclusive and from the 16 <sup>th</sup> day to the last day of each month from Apr. 1 to Nov. 30, inclusive |

B. By inserting in Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

|-----------------------------|--------------------------|--|---|
| Cayuga Avenue               | North                    | A point 101.9 metres east of Avon Avenue and a point 5.5 metres further east | From the 16 <sup>th</sup> day to the last day of each month from Apr. 1 to Nov. 30, inclusive |

| Cayuga Avenue               | South                    | A point 86.5 metres east of<br>Avon Avenue and a point<br>5.5 metres further east | From Dec. 1 of one<br>year to Mar. 31 of the<br>next following year,<br>inclusive and from the<br>1 <sup>st</sup> day to the 15 <sup>th</sup> day<br>of each month from<br>Apr. 1 to Nov. 30,<br>inclusive |
