

**CITY OF TORONTO**

**BY-LAW 350-2020**

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Harbord Street, Roxton Road.**

The Council of The City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Roxton Road	East	Harrison Street and Harbord Street	Anytime

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Roxton Road	East	Harrison Street and Dewson Street (south intersection)	Anytime

C. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Roxton Road	East	Dewson Street (north intersection) and Harbord Street	Anytime
Roxton Road	West	Dewson Street (north intersection) and Dewson Street (south intersection)	Anytime

D. By deleting from Schedule XVIII (One-Way Highways) in § 950-1317, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Between)	(From Column 3 Times and/or Days)	(In Column 4 Direction)
Roxton Road	Dundas Street West and Bloor Street West	Anytime	Northbound

E. By inserting in Schedule XVIII (One-Way Highways) in § 950-1317, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Times and/or Days)	(In Column 4 Direction)
Roxton Road	Dundas Street West and Dewson Street (south intersection)	Anytime	Northbound
Roxton Road	Dewson Street (north intersection) and Harbord Street	Anytime	Northbound
Roxton Road	Harbord Street and Bloor Street West	Anytime	Southbound

F. By inserting in Schedule XIX (One-Way Traffic Lanes) in § 950-1318, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Lanes)	(In Column 4 Times and/or Days)	(In Column 5 Direction)
Roxton Road	Dewson Street (north intersection) and Dewson Street (south intersection)	2 Easterly Northbound	Anytime	Northbound
Roxton Road	Dewson Street (north intersection) and Dewson Street (south intersection)	Westerly Southbound	Anytime	Southbound (bicycles only)

G. By inserting in Schedule XXIII (Prohibited Turns) in § 950-1322, the following in alphabetical order by street name:

(In Column 1 Intersection or Portion of Highway)	(In Column 2 Direction)	(In Column 3 Turns Prohibited)	(In Column 5 Times and/or Days)
Harbord Street and Roxton Road	Eastbound	Left	Anytime

(In Column 1 Intersection or Portion of Highway)	(In Column 2 Direction)	(In Column 3 Turns Prohibited)	(In Column 5 Times and/or Days)
Harbord Street and Roxton Road	Westbound	Right	Anytime

H. By inserting in Schedule XXVII (Compulsory Stops) in § 950-1326, the following in alphabetical order by street name:

(In Column 1 Intersection)	(In Column 2 Stop Street or Highway)
Roxton Road and Dewson Street (south intersection)	Roxton Road (southbound bicycle traffic)
Roxton Road and Harbord Street	Roxton Road (southbound)
