

CITY OF TORONTO

BY-LAW 355-2020

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Sumach Street.

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Sumach Street	East	Queen Street East and Shuter Street	First day to the 15 th day of each month, from Apr. 1 to Nov. 30, inclusive
Sumach Street	East	Queen Street East and Shuter Street	Anytime, from the 1 st day to the 15 th day of each month, Apr. 1 to Nov. 30, inclusive
Sumach Street	West	Queen Street East and Shuter Street	Anytime, from the 16 th day to the last day of each month, Apr. 1 to Nov. 30, inclusive; Anytime, from Dec. 1 of one year to Mar. 31 of the next following year, inclusive
Sumach Street	West	Queen Street East and Shuter Street	16 th day to the last day of each month, from Apr. 1 to Nov. 30, inclusive

B. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Sumach Street	East	Queen Street East and Shuter Street	Anytime

C. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

E. By deleting from Schedule XVIII (One-Way Highways) in § 950-1317, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Between)	(From Column 3 Times and/or Days)	(From Column 4 Direction)
Sumach Street	Queen Street East and Shuter Street	Anytime	Southbound

F. By inserting in Schedule XIX (One-Way Traffic Lanes) in § 950-1318, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Lanes)	(In Column 4 Time and/or Days)	(In Column 5 Direction)
Sumach Street	Queen Street East and Shuter Street	Easterly Northbound	Anytime	Northbound (bicycles only)
Sumach Street	Queen Street East and Shuter Street	2 Westerly Southbound	Anytime	Southbound

G. By inserting in Schedule XXVII (Compulsory Stops) in § 950-1326, the following in alphabetical order by street name:

(In Column 1 Intersection)	(In Column 2 Stop Street or Highway)
Sumach Street and Shuter Street	Sumach Street (northbound bicycle traffic)
